Incident report of Election Spl train No.00328 Ex-SMBX - RSD dt.07.10.2024

Complaint matter: An X post on Amar Ujala got viral stating that CRPF troops did not got food for the last 48 hours in Election Special train no. 00328.

IRCTC Remarks and Action Taken

- 1. The EST 00328 was scheduled to depart from Sambha on 07.10.2024 at 2300 hrs. But the train departed on 08.10.2024 at 03.15 hrs i.e. more than 4 hours late from the originating point i.e. Sambha.
- 2. The PAD items (Namkeen, Juice, Banana, Biscuits & Railneer bottle) were supplied from Ludhiana with Excellent Feedback.
- 3. Breakfast was provided from Ambala station at 1335 hrs on 08.10.2024 comprising Poori with Aloo Bhaji, Chocolate, Biscuit, Bread Slices, Banana, Cutlet, Pickle with Tea, Rail neer with Excellent feedback.
- 4. The Lunch service was converted to Dinner service station and provided at 1945 hrs on 08.10.2024 at Delhi Safadarjung station. (Dinner Plain Rice, Rajma Masala, Kadhi Pakoda, Mix Veg., Sweet, Banana, Curd, Pickle and Rail Neer bottle). The remarks on challan were "food is not freshly made". However the IRCTC official informed the commandment that the food was prepared fresh on date.
- 5. Next day morning i.e. on 09.10.2024, the troops were provided full Breakfast along with Emergency meal at Jhansi at 0930 hrs. (Breakfast comprises of Pooris, Mix Veg. Aloo Bonda, Biscuit, Bread, Banana, Pickle, Tea and Rail Neer bottle, Emergency Meal comprising of Namkeen, Juice, Biscuit, Banana, Rail Neer with Excellent and Satisfactory feedbacks.

Thereafter the train entered into WZ jurisdiction.
