
**Subject: Release of Admit Cards to the candidates for Physical Standard Test (PST)/Physical Endurance Test (PET) for the post of Constable (Armed/IRP/SDRF/Executive), advertised vide Notification No. 01 of 2024, Item Nos. 01, 02, 05, 06.**

1. In continuation to this office Notice No. JKSSB-COE0EXAM(UT)/36/2024-03 (7593651) Dated:29-07-2025, it is hereby notified for the information of the candidates that the Physical Standard Test (PST)/Physical Endurance Test (PET) for the post of Constable (Armed/IRP/SDRF/Executive), advertised vide Notification No. 01 of 2024, Item Nos. 01, 02, 05, 06 shall be held from **24<sup>th</sup> September, 2025** at **M. A. Stadium, Jammu** of those candidates who had opted for **Jammu as their test venue**:
2. It is further notified that: -
  - i. Admit Cards for the candidates appearing for the PST/PET shall be hosted on official website of JKSSB ([www.jkssb.nic.in](http://www.jkssb.nic.in)) from **18-09-2025**.
  - ii. Candidates can download their Admit Cards from the official website of JKSSB by using their Application Id. They must read the instructions contained therein, carefully.
  - iii. In case of any difficulty in downloading/issues related to Admit Card, candidate(s) may contact the JKSSB Help-Desk at 0191-2461335 (Jammu)/0194-2435089 (Srinagar), during office hours.
  - iv. Candidates are also advised to visit the JKSSB's official website ([www.jkssb.nic.in](http://www.jkssb.nic.in)) for the latest updates on the examinations and Admit cards will not be sent by post.
  - v. The candidature of candidates claiming eligibility by misrepresentation/concealment of any material facts, impersonation, fraud, etc. shall be liable for cancellation and disciplinary action, as deemed appropriate.
  - vi. The Board reserves the right to cancel the candidature of any candidate at any stage at which he/she is found ineligible in terms of the Rules/Regulations.
  - vii. It is notified for the information of all the shortlisted **Ex-Servicemen (ESM)** candidates, who are appearing for the PST/PET to bring the Matriculation certificate (as age proof) mandatorily on the day of PST/PET along with other supporting documents. No ESM candidate shall be allowed to appear in the PST/PET without the production of relevant documents at the time of the test.
  - viii. It is notified for the information of all the shortlisted candidates belonging to the **Gorkha Community and Bot Tribe**, who are appearing for the PST/PET to bring the category certificate (Gorkha/Bot community certificate issued by the competent authority) mandatorily on the day of PST/PET along with other supporting documents to avail the benefits of the relaxed standard of PST, if any.
  - ix. Candidates are required to appear in the PST/PET on the schedule date, time and venue. A candidate, who fails to appear in the PST/PET on the given date, shall forfeit his/her right of consideration at any stage.
  - x. **The candidates appearing in the aforesaid tests are advised in their own interest to reach the examination city at least one day prior to the scheduled date of their test. This is to**

**ensure timely reporting at the venue and to avoid any inconvenience due to unforeseen circumstances such as road blockades, adverse weather conditions, or other delays.**

- xi. **The candidates should be in proper attire during the PST/PET and no candidate shall be allowed to participate wearing improper dress.**
  - xii. In case of any deficiency with reference to eligibility etc., proved at the time of PST/PET, the candidate shall not be allowed to appear in the PST/PET. If any deficiency is found subsequently, the candidate shall not be considered for selection and will be treated as disqualified.
  - xiii. Any candidate found guilty of impersonating or submitting fabricated/tampered documents/testimonials or making false and incorrect statements or suppressing material information shall render him/her liable for criminal prosecution under law, which shall include permanent debarment or debarment for a specific period, for consideration of any or all recruitments, made by the Board. Also canvassing/lobbying in any form will entail disqualification of the candidate.
  - xiv. Any candidate found misleading the Board/Committee(s) by trying to appear more than once, in the PST/PET shall be liable for prosecution under norms.
  - xv. The PST/PET is of qualifying nature only.
  - xvi. No TA/DA shall be paid for participation in the PST/PET.
3. Stepwise procedure to download JKSSB E-Admit Card:
- i. To download E-Admit Card, first visit the official website of JKSSB, i.e., [www.jkssb.nic.in](http://www.jkssb.nic.in).
  - ii. On the homepage, there will be an option to download **E-Admit Card**.
  - iii. On that page, click on the link/button - "**LOGIN**".
  - iv. Enter log-in credentials, i.e., **Application Id**.
  - v. Click on the '**View and Print E-Admit Card**' button.
  - vi. The JKSSB E-Admit Card will appear on the screen.
  - vii. Candidate must bring the clear printed copy of the E-admit card on the day of their PST/PET.
  - viii. Download and Print your JKSSB E-admit card.
