### CORRIGENDUM

**Subject: - Declaration of Result of Combined Graduate Level Examination (Tier-I), 2025.**

**No. HQ-C11018/5/2025-C-1:** Candidates may refer to the result write-up of CGLE 2025 (Tier-I), uploaded on the website of the Commission on 18.12.2025. Marks of the qualified/non-qualified candidates of Tier-I were made live on 09.01.2026. Subsequently, a few representations were received from candidates claiming that their name is not featuring in any of the published Lists (List-I, II or III) despite having more marks than the cut-off mentioned for various categories in para 5 of the Result Write-up of CGLE 2025 (Tier-I).

2. The matter has been examined comprehensively and List-I, II and III, annexed with the result write-up of CGLE-2025 (Tier-I), have been found in order. However, the Table under para 5 i.e. **"List-3 - Candidates shortlisted in CGLE (Tier-I) for appearing in Tier-II (Paper-I) (for all posts Other than JSO and Statistical Investigator Grade-II)"** did not reflect the correct 'cut-off marks' and 'number of candidates available' in respect of the categories mentioned in the table below due to an inadvertent error. Accordingly, the correct Table is as under:-

3. It is pertinent to mention that this correction has not resulted in any addition or deletion from the earlier published List-III and does not affect the result of any candidates.

4. Further, representations have also been received regarding normalization process in respect of the candidates who have been rescheduled to take the CGLE 2025 Tier-I exam on 14<sup>th</sup> October, 2025. On the recommendations of the Committee of Experts constituted for the purpose, they have been clubbed with their original shifts and their marks have been normalized accordingly.

5. The other contents of the **Result Write-up dated 18.12.2025 of CGLE (Tier-I)** shall remain unchanged.
