TERMS & CONDITIONS

1. Aspiring applicants satisfying eligibility criteria in all respect can submit their **application ONLINE only**. On-line application(s) will be available on AIIMS, RISHIKESH web site www.aiimsrishikesh.edu.in w.e.f **14.02.2026 10.00 hrs to Last date 23:59 hrs as mentioned above**
2. Applicants must fulfil all essential eligibility criteria (educational qualification, age limit, experience etc.) by last date of submission of application forms in respect to that post for which they are applying.
3. Amount of **non-refundable fee** to be paid in respect of one post is as under:-

4. **On-line Registration and Submission process will be terminated by 23:59 hrs on Last date as mentioned above.** Candidature of such applicants who fail to complete online submission of application form by stipulated date and time will not be considered and no correspondence in this regard will be entertained.
5. Age relaxation for OBC candidates up to a maximum period of 03 years as on last date of submission of application as specified above. The vacancies are being advertised in financial year 2025-2026, therefore, **OBC (NCL) certificate issued during the period from 01.04.2025 to 31.03.2026 will be considered valid**. Candidates who have OBC (NCL) certificate issued before or after this period (i.e. 01.04.2025 to 31.03.2026), will not be considered valid for this advertisement. Candidates applying under OBC category must produce the valid caste certificate in the format provided by the DoP&T vide O.M. No. 36036/2/2013-Estt. (Res.) dated 30.05.2014 and further clarification issued by DoP&T OM No. 36036/2/2013- Estt(Res-I) dated 31.03.2016. Certificate must be valid for employment in Central Government Institutions. OBC candidate's eligibility will be based on Castes borne in the Central List of Govt. of India. Their Sub-caste should also match with the entries in Central List of OBC, failing which their candidature as OBC candidate will not be considered. The OBC certificate should clearly show that the applicant does not belong to the Creamy Layer.

6. Age relaxation for SC candidates up to a maximum period of 05 years as on last date of submission of application as mentioned above. Eligibility under SC category will be applicable as per Govt. of India guideline. Certificate should be issued by Tehsildar or above rank officer in standard format of Central Government.
7. Age Relaxation, in case of Permanent Government Employees who have rendered not less than 3 years regular and continuous service in the relevant field as on last date of submission of online application, relaxable upto a maximum period of 5 years.
8. No relaxation would be available to SC/ST/OBC candidates applying for unreserved vacancies.
9. **Reservation policy will be as per Government of India guidelines issued time to time.**
10. If a candidate indicates in his/her application form that he/she belongs to EWS/SC/ST/OBC/General category but subsequently writes to the institute to change his/her category, such request shall not be entertained by the institute.
11. Canvassing of any kind will lead to disqualification.
12. Prescribed qualification is minimum and mere possessing of same does not entitle any candidate for selection.
13. Appointment is full time and private practice of any type is prohibited.
14. He/ She is expected to conform to rules of conduct and discipline as applicable to institute employees.
15. Employees of Institute will be governed by New Pension Scheme as per provision contained in Ministry of Finance, Department of Economic Affairs (ECB & PR Division). Notification No. 5/7/2003-ECB&PR dated 22.12.2003.
16. Candidate should not have been convicted by any Court of Law.
17. No documents including printed/hard copy of online application form are required to be sent by post. However, applicants are advised to keep one printed/hard copy of their application forms for submission at time of Interview.
18. Applicants working under Central/State/UT Government or Government Organizations/PSUs/Autonomous Bodies are required to submit a **“NO OBJECTION CERTIFICATE”** from their current employer at the time of Interview/ Document Verification or as asked by the Institute without which they will not be allowed for further recruitment process.
19. **Mode of selection** may be Interview and/or written test or both as per decision of the Competent Authority.
20. The Candidates are advised to regularly visit the Institute website for information related to Written Test/Interview Schedule and other updates.
21. **No TA/DA shall be admissible for appearing in Written Test / Interview or both.**
22. In case any information given or declaration by candidate is found to be false or if candidate has willfully suppressed any material information relevant to this appointment, he/she will be liable to be removed from service and any action may be taken against him as deemed fit by appointing authority.
23. Decision of competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.
24. Appointment of selected candidates is subject to his/her being declared medically fit by the competent Medical Board.
25. Period of Probation shall be of two years.
26. Extension for date of joining will not be granted except in exceptional circumstances, as decided by AIIMS administration.
