It is for information of all concerned that, in view of the pandemic situation created by COVID19, the Commission have been pleased to introduce digital verification of original documents of the candidates. The candidates bearing following Registration Ids, applied for Recruitment to the Posts of Asst. Director of Textiles, pursuant to Advertisement No.14 of 2019-20 are required to upload the scan copy of their original certificates, mark sheets and other documents in the website of the Commission (www.opsc.gov.in), through the link to be available w.e.f. 26.08.2020 till 05.09.2020 for digital verification of their documents. **The candidature of the candidates, who wouldn't upload the scan copy of the required documents in the above schedule, will be rejected and no correspondence on that score will be entertained.**

It is also made clear that, the candidature of these candidates for the recruitment is purely provisional. This verification is for purpose of shortlisting of candidates to be called for interview. However, those shortlisted candidates, who shall be called for the interview, must have to produce original documents for verification at the time of interview. The detailed information of shortlisted candidates and date of interview shall be intimated in due course.

List of Original Documents to be uploaded for digital verification

1. H.S.C. or equivalent Certificate in support of declaration of age issued by the concerned Board/Council;
2. P.U./P.P./Intermediate/Higher Secondary/+2 Examination/Diploma Examination Certificate issued by the concerned Board/Council;
3. Degree Certificate in Textile Technology, Spinning and Weaving issued by a recognized Institution or University;
4. Degree certificate in Textile Chemistry;
5. Diploma certificate in Textile Technology or Handloom technology from a recognised Institution;
6. Experience certificate of three years in the Spinning/Weaving Department of a Textile Mill or Handloom Industry or under the State Government

7. Mark lists in support of all the aforesaid examinations (i.e. H.S.C. to Bachelor's Degree) passed including fail marks, if any, issued by the concerned Board/Council/Universities.

NOTE-1

- (a) Candidates who have not been awarded percentage of marks, but only "GRADE MARKS" must upload the scan copy of conversion certificate from the concerned University indicating the actual equivalent percentage of marks and the conversion formula failing which, their candidatures are liable to be rejected.
8. Caste Certificate by birth in support of claim as S.C./S.T. whichever applicable.
9. Required Odia pass certificate from the Board of Secondary Education, Odisha indicating Odia as a language subject equivalent to M.E. School Standard or a certificate from the Principal/Headmaster of the School indicating that the candidate has passed Odia in M.E. Standard, if not passed Odia as a subject in the High School Certificate/equivalent examination;
10. No Objection Certificate from the competent authority.
11. service certificate from the competent authority in case of In-service candidates belonging to Textile Branch under Directorate of Textiles claiming relaxation.

NOTE-1 —

- a. Candidates claiming to be belonging to S.C./S.T. category of Odisha BY BIRTH are required to submit copy of the relevant Caste Certificate issued by the competent authority in the prescribed form. The competent authorities are:- District Magistrate/Collector or Additional District Magistrate or Sub-divisional Magistrate/Sub-Collectors or Executive Magistrates or Revenue Officers, not below the rank of Tahasildar/Additional Tahasildar of Government of Odisha;
 - b. Women candidates belonging to S.C./S.T. category are required to submit caste certificate by birth showing daughter Of” Caste Certificate by virtue of marriage (i.e. showing “wife of”) Will not be accepted.
12. Physically Handicapped candidates are required to attach copy of their identity card issued by the District Social Welfare Officer along with the Disability Certificate (indicating percentage of disability) issued by the concerned Medical Board.
 13. O.P.S.C. copy of Challan (Pay in Slip) for payment of fee at SBI.
- NOTE: Degree Certificate, Caste Certificate, Odia pass certificate and Disability Certificate of Physically Handicapped Persons (wherever applicable) must have been issued by the competent authority within the last date fixed for receipt of Application Form.
