Mali wakes up to military rule after President is forced out

Boubacar Keita says he resigned to avoid bloodshed

Mali awoke on Wednesday to a new chapter in its troubled history after rebel military leaders forced President Boubacar Keita from office, prompting its West African neighbours to threaten border closures and sanctions against the coup leaders.

Mr. Keita, embattled by months of protests over economic stagnation, corruption and a brutal Islamist insurgency, said he had resigned to avoid bloodshed.

There were few obvious traces of the previous day's drama in the capital Bamako – there were no troops on the streets despite the coup leaders announcing a night-time curfew.

The burnt-out home of the former Justice Minister after an attack by protesters was one of the few visible signs of the overthrow.

UN seeks Keita's release

Jubilant crowds had cheered the rebels on Tuesday as they arrived in Bamako, where they detained Mr. Keita along with Prime Minister Boubou Cisse.

UN Secretary General An-

tonio Guterres demanded the "immediate and unconditional release" of both men as diplomats in New York said the Security Council would hold emergency talks on Wednesday.

It was unclear whether Mr. Keita was still in custody on Wednesday at the Kati military base – a facility seized by the mutineers that was also the site of the 2012 coup that brought him to power.

The coup leaders appeared on television overnight to pledge a political transition and new elections within a "reasonable time".

Malian Air Force deputy chief of staff Ismael Wague said he and his fellow officers had "decided to take responsibility in front of the people and of history".

There were no reports of casualties during the military takeover but the coup leaders announced a curfew and border closures, in effect sealing off the country.


French President Emmanuel Macron was among the first to condemn the mutiny, his office saying that he still supported mediation efforts by other West African states.

Mali is the cornerstone of French-led efforts to roll back jihadists in the Sahel, and its neighbours are anxious to avoid the country sliding into chaos.

Colonel Wague said "all past agreements" would be respected, including Mali's support for anti-jihadist missions in the region.

"MINUSMA (the UN force in Mali), (France's) Barkhane force, the G5 Sahel, Takuba (a European special-forces initiative) remain our partners," he said.

The coup leaders also remain "committed to the Algiers process," a 2015 peace agreement between the Malian government and armed groups in the north of the country, he said.

- Examination will be conducted online twice a year in 12 languages and will be based on a common curriculum




- Scores will be valid for a three-year period. Students can write the test multiple times and their best score will be taken into account





Harley-Davidson may exit India

Weak sales and a lack of visibility for future demand are reasons cited

Barely a decade after its entry, Harley-Davidson Inc. is looking to wind down its assembly operations in the country as a result of weak sales and a lack of visibility for future demand, industry executives said.

The iconic U.S. motorcycle maker has sent out feelers to a few automakers




Rough ride: A Harley-Davidson outlet in Vijayawada. • V. RAJU

through consultants for a possible outsourcing arrangement using its leased assembly facility at Bawal in Haryana, a person privy to the preliminary talks said.

The decision is in keeping with its latest 'rewire' strategy to focus on about 50 markets, mainly in North America, Europe and parts of Asia Pacific that represent the "majority of the company's volume and growth potential". In a statement accompanying its second-quarter results last month, Harley-Davidson said: "The company is evaluating plans to exit international markets, where volumes and profitability do not support continued investment in line with the future strategy."

Harley-Davidson India sold fewer than 2,500 units in the last financial year, industry officials said.

Dream11 is IPL's new title sponsor

Fantasy sports platform wins rights for 2020 edition with ₹222 crore bid

Fantasy sports platform Dream11 has bagged the title sponsorship rights for the Indian Premier League's 2020 edition with a bid of ₹222 crore.

Three bids

IPL chairman Brijesh Patel confirmed to *The Hindu* on Tuesday that Dreamii was finalised after "evaluating the three bids that were submitted during the prescribed window earlier today".

The other bidders were elearning platforms Unacademy (₹170 crore) and Byju's (₹201 crore).

The eligible entities among those who had submitted their Expression of Interest (EoI) were asked to email their bids between 11 a.m. and 1 p.m. on Tuesday.

The Tata group, despite



submitting the EoI document last week, pulled out of the race.

The Board of Control for Cricket in India (BCCI) was forced last week to invite bids for IPL's title sponsorship rights following Vivo India's withdrawal barely six weeks before the start of the tournament, to be played in the United Arab Emirates 2008-2012: DLF:

Chinese investor

A combination of the Chinese firm seeking a reduction in the sponsorship amount because of the pandemic-caused economic crisis and the public sentiment in India following the border tension with China had led

to Vivo's exit. Dream11, which has been a partner of BCCI and IPL for a couple of years now, also has a minority investment from a Chinese firm — Tencent Holdings.

Vivo India's deal was valued at ₹440 crore per annum.

FanCode, a live-streaming app launched last year by the Dream11 promoters, is under investigation by the BCCI's Anti-Corruption Unit for its alleged links to a match played by locals on the outskirts of Chandigarh, that was passed off as a T20 contest staged in Sri Lanka.

A BCCI official said that since the Punjab Police is investigating the matter and the two sites are different entities, the on-going investigation will not have any bearing on Dream11's bid.





CSE probe finds software tweaked to clear blocks in dense forests for auction

Since 2015, of the 49 blocks cleared for coal mining, nine were in 'No-Go' areas, or regions that were once classified by the Ministry of Environment and Forests and Climate Change as containing very dense forests and hence closed to coal mining. In 2020, of the 41 blocks put up for auction, 21 feature in the original No-Go list, the Centre for Science and Environment (CSE) said at a webinar on Tuesday.

The meeting was organised to present results of an investigation into coal block auctions.

On June 18, Prime Minister Narendra Modi launched the auction of 41 coal blocks through video-conference. A two stage e-auction is being adopted for the allocation of mines. The decision was

part of the announcements made by the Centre under the Aatmanirbhar Bharat Abhiyan.

Though new blocks were being auctioned, the CSE investigation, published in the organisation-owned magazine Down To Earth (DTE), pointed out that currently India was not utilising its existing capacity fully and that a Right To Information response by the Union Coal Ministry revealed that 67% of the mines auctioned since 2015 are were not operational vet. From 2015-2020, the government tried to auction 112 mines, but succeeded in only 42 cases.

Several potential coal reserves are located in dense forests particularly in Chattisgarh and Madhya Pradesh. The government determined which of them were too ecologically important to touch,



and which were amenable to be opened up using a 'decision support system software' that rated forest lands on environmental parameters. In some cases, the CSE investigation found that results of the software evaluation were "tweaked" to make 'No-Go' land into 'Goforests'. It also found that officials from the Coal Ministry, the beneficiary organisation, were "deputed" to work with the Forest Survey of India to "rework" conditions and clear forests for mining.

DTE editor and CSE Director-General Sunita Narain said in a statement: "Our forests are where our coal reserves are - forests and coal are intrinsically linked in India. And our poorest people live in these areas, which also hold our most abundant watersheds. If at all we must mine coal, which itself has serious pollution implications, we need to do so after careful consideration that we have taken utmost care not to destroy forests needlessly and this means the need to optimise on current mines - not mine more".

Japanese bulk carrier MV Wakashio struck a coral reef off the capital, Port Louis, in July 2020 resulting in an oil spill of over 1,000 tonnes into the Indian Ocean.






RBI releases framework for pan-India entity for retail payments

- Reserve Bank of India has unveiled the framework for setting up of pan-India Umbrella Entity for Retail Payments.
- As per the framework, the companies with a net worth of over 500 crore rupees will be eligible to set up an umbrella entity which among other things will be permitted to set up, manage and operate new payment systems in the retail space comprising ATMs White Label Pos, Aadhaar-based payments and remittance services.









► The entity that will focus on retail payments systems would be incorporated under the Companies Act, 2013.


