Plea claimed the company was storing sensitive data flouting Central bank rules

The Delhi High Court on Monday sought response of the Centre and the Reserve Bank of India (RBI) on a plea seeking action against 'Google Pay' for allegedly violating the central bank's guidelines related to data localisation, storage and sharing norms.



A Bench of Chief Justice D.N. Patel and Justice Prateek Jalan also issued notice to Google India Digital Service Pvt Ltd on the petition of advocate Abhishek Sharma seeking to impose penalty on the company for alleged violations of laws. The court has posted the case for further hearing on September 24.



The petition sought direction to Google India Digital Service to give an undertaking to not store data on its app under UPI ecosystem and further not to share it with any third party, including its holding or parent company.

It also sought direction to the company not to share any data from UPI switch with any other party.

Third-party app

The plea stated that Google India launched, 'Tez', a mobile payments service targeted at users in India which later folded into the new 'Google Pay' app. It said 'Google Pay' is a third-party app which facilitates payment in the UPI ecosystem and is able to do the same by partnering with various PSP/ acquirer banks.

"Further, 'Google Pay' is regulated by respondent number 2 [National Payment Corporation of India] which is responsible for granting permission to Payment Service Provider [PSP] as banks and to third-party apps to operate under the UPI network," it said.

The plea claimed that the company was storing personal sensitive data in contravention of UPI procedural guidelines of October 2019, which allows such data to be stored only by PSP bank systems and not by any third-party application.

The plea sought direction to the RBI to take appropriate punitive action against the NPCI and revoke its authorisation to operate and regulate the UPI payment system, on account of risking customer payments data, its failure to audit Google India Digital Service Pvt Ltd and take any steps against it despite its acts of flagrant and serious noncompliance of applicable laws.

Guwahati gets India's 'longest' river ropeway


People dependent on ferries can now cross river in a jiffy

India's 'longest' passenger ropeway across a river was unveiled in Guwahati on Monday, almost a year after it was completed.

The 1.82-km bi-cable jigback ropeway connects a forest campus near the Kamrup (Metro) Deputy Commissioner's office in the city on the southern bank of the Brahmaputra and a hillock behind the Doul Govinda temple in north Guwahati on the other.

The ropeway passes over the mid-river Peacock Island that houses Umananda, a medieval Shiva temple.

China launches warship for Pakistan Navy

China has launched first of the four advanced naval warships it is building for Pakistan, amid deepening defence ties between the two all-weather allies.

The launching ceremony for the first warship was held at the Hudong Zhonghua Shipyard in Shanghai on Sunday.

Pakistan-China defence ties turn a new chapter with the launch of the first ship of Type-054 class frigate, Pakistan's state-run APP news agency reported.

The Type-054 class, equipped with the latest surface, subsurface, anti-air

Pandemic reaches the tribal community in Malkangiri

The COVID-19 pandemic has reached the Bondas, a tribal community residing in the hill ranges of Malkangiri district in Odisha. Four members of the community have tested positive for COVID-19. They have been isolated from the rest of the community members.

bondas, a particularly vulnerable tribal group (PVTG), live in settlements comprising small butments in the hills of the Khairaput block. Their population is around 7,000.

"Three persons from the Bonda community from Mudulipada village and one




Virus spread: Bondas live in settlements in the hills of Kbairaput block of Malkangiri. • SPECIAL ARRANGEMENT

have recovered, active cases stand at 17.

Odisha is home to 62 tribal communities – the largest diverse groups of tribal population in India. Thirteen of them are PVTGs. Tri171 persons have been found infected in Lanjigarh block of Kalahandi district, where the Dongrias live. Cases were also detected in Lahunipada (Sundargarh), Barkot (Deogarh) and Pallahara

भारतीय विमानपत्तन प्राधिकरण (AAI)

भारतीय विमानपत्तन प्राधिकरण (AAI) का गठन संसद के एक अधिनियम द्वारा 1 अप्रैल, 1995 को किया गया था, तब से यह प्राधिकरण ग्राउंड (Ground) और एयर पेस (Airspace) दोनों में नागरिक उड्डयन अवसंरचना के निर्माण, उन्नयन, रखरखाव और प्रबंधन का कार्य कर रहा है।



वर्तमान में भारतीय विमानपत्तन प्राधिकरण (AAI) विमानपत्तनों का प्रबंधन करता है, जिसमें 23 अंतर्राष्ट्रीय विमानपत्तन, 10 सीमा शुल्क विमानपत्तन, 81 घरेलू विमानपत्तन तथा रक्षा वायु क्षेत्रों में 23 घरेलू सिविल एन्क्लेव शामिल हैं।
