Important Instructions to the Candidates for the Post of Trained Graduate Teachers

(TGTs):I: For the post of TGT (S.ST.):

- i) **The candidate should have studied any two subjects out of the following:**
- ii) **History with at least 50% marks in aggregate and one subject out of Geography/Economics/Political Science with at least 50% marks in graduation.**
OR
- iii) **Geography with at least 50% marks with History/Economics/Political Science with at least 50% marks in aggregate and also at least 50% marks in graduation.**
- iv) **Geography/History should have been studied in all the years of graduation with at least 50%marks.**
- v) **In case of Honors Degree in History, the candidate should have studied Geography/Economics/Political Science in first and/or second year of graduation with at least 50%marks in History in aggregate and at least 50% marks in other subjects indicated above at graduation level and also at least 50% marks in aggregate at graduation level.**
- vi) **Similarly, in case of Honors degree in Geography, the candidate should have studied History/Economics/Political Science in first and/or second year of graduation with at least 50%**

marks in Geography in aggregate and at least 50% marks in other subjects indicated above at graduation level and also at least 50% marks in aggregate at graduation level.

II: For the post of TGT(Maths)

- a) The candidate should have studied Maths in all the years of graduation with any two subjects out of Physics, Chemistry, Electronics, Computer Science, Statistics.
- b) In case of Honors Degree in Maths, the candidate should have studied Maths in all the years of graduation with at least 50% marks in aggregate and any of the two subjects indicated in point No.1 above with at least 50% marks in each subject at graduation level and also at least 50%marks in graduation.
- c) BA (Hons.) in Maths and B.SC (Hons.) in any subject other than Maths are not eligible for the post of TGT(Maths).

5.	Games Coach	Essential Qualification: Graduation with recognized Diploma in Physical Education or B. P. Ed. Participation in State/National level games/sports will be given preference. Experience and expertise in the field is a must.
6.	Regional Language Teacher (ODIA):	Essential Qualification: Graduate with Honors in Odia with minimum 50% marks and B.Ed. from a recognized university. In case of non-availability of Honors Graduate in Odia, candidates having Odia as a subject in Graduation may be considered.
7.	Guidance counsellor	BA/ B.Sc. (psychology) with certificate of Diploma in counselling from a recognize institute or regular one year Post Graduate Diploma in Guidance and Counselling
8.	Nurse	Diploma holder in nursing. Experience candidate will be preferred.

Relaxation in CTET: In absence of CTET qualified candidate, candidate without CTET qualification may be considered if otherwise eligible as per KVS recruitment rules. (F.No.11029/39/2011/KVS(HQ)/Acad. Dated:08/10/2013)

Terms & Conditions:

- i) NO TA/DA shall be paid for appearing in walk-in-interview.
- ii) Appearing in interview does not confer the right to appointment on contractual basis. Part-time contractual appointment is subject to vacancy exists/arises or when a teacher proceeds on long leave. Teachers engaged on contractual basis, would have no claim or right for appointment on a regular basis nor will they be a part of the cadre of teachers of Kendriya Vidyalaya.
- iii) The part-time contractual teachers will be engaged till such time the regular teacher join or the end of the academic session, whichever is earlier. Contrary to the above the services of a part time contractual teacher can be terminated any time if his/her performance is not up to the mark.
- iv) Teachers appointed on contractual basis will not be entitled for vacation pay and during Autumn/Winter Break payment shall be calculated on pro rata basis.
- v) Teacher will not be entitled for pay, if remains absent on working day. In case of absence from duty, payment will be calculated on pro rata basis.
- vi) The panel drawn on the basis of interview will be valid for one academic session (2021-22) only. Selected candidates will be informed over phone or by e-mail only candidates are to provide valid phone-number & e-mail Id. In case a candidate does not respond within 3 days the next in the panel will be given chance and the candidature of the first candidate will stand forfeited.
- vii) Teachers appointed on Part-Time Contractual basis have to follow the rules and regulations of KVS.
- viii) Working hour shall be same as regular teacher.

Duties of Contractual Teacher:

Teachers appointed on contractual basis will discharge following duties:

- a) Regular classroom activity/Copy Checking.
- b) Invigilation Duty/Evaluation work.
- c) Helping students and colleagues in preparation and organization of different curricular/Co- curricular activities in the Vidyalaya.
- d) All other works assigned by the principal.

NB:

1. Candidates who have qualified in the CTET conducted by CBSE will be given preference for the post of TGT & PRT.
2. Maximum age limit for applying for all teaching post is 65 years as on 31.03.2021 and no age limit for KVS retired employees.

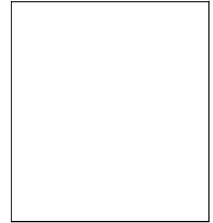
